### **1910.120 - Hazardous waste operations and emergency ...**

operations involving hazardous wastes that are conducted at treatment, storage, and disposal facilities regulated by Title 40 Code of Federal Regulations Parts 264 and 265 pursuant to RCRA, or by agencies under agreement with U.S. Environmental Protection Agency to implement RCRA regulations; and; emergency response operations for releases of, or substantial threats of releases of, hazardous substances regardless of the location of the hazard.

Part 172 of 49 CFR contains the hazardous materials communication requirements in addition to the hazardous materials table, emergency response requirements, training, and security plan. The term hazardous materials communications commonly

Occupations for which the HAZWOPER Standard most commonly applies include Hazardous Materials (HAZMAT) Response Teams, Fire Departments, Police Departments, employees who conduct environmental investigations at uncontrolled hazardous waste sites, employees who work at facilities that utilize bulk quantities of hazardous materials, and employees who are likely to discover an uncontrolled release.
