The Medicare Part D Extra Help program helps Medicare beneficiaries with limited income and resources pay for prescription drug coverage. Eligible beneficiaries receive subsidized premiums, deductibles, and co-

payments.

Part D Low Income Subsidy

Extra Help is a federal program that helps pay for some to most of the out-of-pocket costs of Medicare prescription drug coverage. It is also known as the Part D Low-Income Subsidy (LIS). If your monthly income up to \$1,538 in 2018 (\$2,078 for couples) and your assets are below specified limits, you may be eligible for Extra Help.

Beneficiaries with Medicare who have limited income and assets may qualify for Extra Help with the costs of their prescription drugs. This program is also known as LIS, or the Part D Low Income Subsidy. The Social Security Administration (SSA) and the Centers for Medicare & Medicaid Services (CMS) work together to provide the benefit.

You may qualify for the low-income subsidy available under Medicare Part D if: Your annual income and assets are below the eligibility thresholds. drug plan costs, including Part D premiums, deductibles and copayments. Depending on your income and assets, you may qualify for the full subsidy or a partial subsidy.

Eligibility for Low-Income Subsidy | CMS

The Low-Income Subsidy program may help with Medicare Part D costs like premiums, deductibles, copayments, and other prescription drug costs. For example, in 2019, those who get the Low-Income Subsidy won't pay more than \$3.40 for a covered generic prescription drug or \$8.50 for a covered brand-named medication.

The Medicare Extra Help (or Low-Income Subsidy) program is for people who need financial assistance with their Medicare Part D coverage.

2021 State Low-Income Subsidy Benchmark Premium Amounts

If a person receiving the low-income subsidy enrolls in a Medicare Part D plan that has a premium higher than their state's benchmark premium, the beneficiary is responsible for paying the difference in premiums - unless the difference between the benchmark premium and the plan premium are relatively small (please see the explanation of the de minimis premium policy below*).
