In Scotland, a particular type of electronic signature, an 'advanced electronic signature' must be used to sign the types of document that ROWA says must always be created in writing (namely documents for the constitution of rights in relation to land, gratuitous unilateral obligations and some trusts). Such electronic documents must be 'authenticated by each granter' which means that an advanced electronic signature "which is uniquely linked to the signatory, capable of identifying ...
