The cover letter should be short and address the specific components of the RFE, so that you can show the USCIS officer handling your case that you provided all of the requested information. Include the following items in your Request for Evidence response to USCIS: Original RFE (must be on top) Cover letter (view a sample) All requested evidence

### **\*\*RFE Response to USCIS Sample Cover letter\*\***

The USCIS RFE response review time can vary widely from case to case and will generally depend on the number of applications that are being processed at that time. For example, during the H-1B visa processing, a high number of RFEs are typically issued. This means response review times are known to stretch past 3 months.

### **How to Respond to a USCIS Request for Evidence (RFE)**

USCIS provides an envelope for RFE and NOID responses. This envelope has a barcode printed on it that is used by USCIS as it continues to process the case, so it should be used if the entire response—including a copy of the RFE or NOID, the cover letter, and all exhibits—fits inside.

### **RFE USCIS: Everything You Need to Know**

**Response Due Date:** Any response to an RFE, NOID, NOIR, or NOIT received within 60 calendar days after the response due date set in the request or notice will be considered by USCIS before any action is taken. Any Form I-290B received up to 60 calendar days from the date of the decision will be considered by USCIS before it takes any action.

Typically, a petitioner has only one opportunity to respond to an RFE—once a response is received by USCIS, the agency will move forward with adjudication. If a petitioner sends an incomplete...

### **Who's Afraid of an RFE? Request for Evidence via USCIS**

Once you submit the appropriate paperwork in response to the RFE, you can expect to hear back from USCIS within the next 60 days about their decision or what further action is needed. If you don't respond to the RFE in time, USCIS will only base their decision on what information you initially provided and will most likely deny the application.

Once you have gathered all the evidence requested, arrange the response packet with the original RFE on top, followed by a cover letter, and then all the requested documents presented in the order in which they were requested in the RFE. Once you have completed the response packet, make an exact copy for your records. Send the response to USCIS

## **USCIS RFE Response Review Time | Guidance from NNU Immigration**

After USCIS receives the response to an RFE notice, further action will generally occur within 60 days, but may take longer for some cases. After the NIW I-140 petition submission, it is not rare that an alien applicant receives a Request For Evidence (RFE) letter from a USCIS Service Center.

## **Sample Cover Letter for Response to Birth Certificate RFE**

Some RFEs will simply tell you which documents USCIS is missing. For example, the RFE might ask you to provide a copy of the pages of your passport or your spouse's birth certificate. If you sent only the first page of a bank statement, it might ask you for the remaining pages.

USCIS issued a Request for Evidence (RFE) that called into question both the employer's ability to pay the offered wage and the beneficiary's qualifications. The RFE challenged that the submitted W-2 did not belong to the beneficiary, and that evidence of the employer's ability to pay the full wage from the priority date onward was required.

USCIS officers have clear guidance on how to review an application for a green card and other immigration applications.

The USCIS Policy Manual, in addition to outlining general eligibility requirements, has charts and checklists that officers can use while reviewing applications. These guidance materials define the situations where issuing an RFE is appropriate.

### **USCIS Expands Flexibility for Responding to USCIS Requests**

USCIS will review the issue raised but will not respond to the individual inquiry; Emailing RFEs to this address does not replace the requirement to respond to the RFE within the period stated on the RFE Notice. You should respond to the RFE in a manner you feel is appropriate. Failure to respond to the RFE could result in a denial.
